### MEDICAL DEVICE DESCRIPTION

Items of various sizes and weights made of 100% absorbent cotton, carded and/or water-treated in accordance with the European Pharmacopoeia.



It is recommended to read this leaflet carefully before using the medical device.

#### TECHNICAL DATA

Material: 100% cotton

#### FIELD OF APPLICATION AND INTENDED USE

Non-invasive device for use as an aid in daily dressing activities that is not placed in contact with injured skin or mucosa.

### **UNINTENDED USE**

No use other than those described in the paragraph "FIELD OF APPLICATION AND INTENDED USE" is intended.

- It is also absolutely forbidden:
- Use by persons allergic to cotton.
- Use by children.
- Use by individuals with limited cognitive abilities.

### LIMITATIONS OF THE MEDICAL DEVICE

- Absorbent cotton does not cure any disease.
- The medical device can only be used once as it is disposable.

#### RESIDUAL RISKS.

- It is absolutely forbidden to make any modifications to the medical device. Any damage resulting from the use of the device, improperly modified by an unauthorized operator, relieves the manufacturer of all liability.
- Carefully keep this manual, which is necessary for the proper and safe use of the medical device.
- If the packaging shows breaks that could contaminate the device and make it unusable, we suggest informing the retailer.

## SIDE EFFECTS

There are no side effects to report in the instruction manual. However, do not apply the product to the skin when there is an open wound or irritation. In case of irritation caused by the product, stop application immediately and consult a doctor to check for cotton allergy.

#### CONTRAINDICATIONS

The medical device may cause irritation on individuals who are particularly sensitive or allergic to cotton material.

### **STORAGE**

- Store the medical device indoors cool and dry, away from weather and steam jets.
- Store the medical device away from heat sources, open flames and direct sunlight.
- Store the medical device, before use, inside its original packaging.

# USE

- Sanitize hands by washing them thoroughly with soap and water before use
- Take cotton and if necessary dip it in a disinfectant and/or similar substances.
- Gently dab the affected body part.
- Disposable
- Non-sterile

## **WARNINGS**

- AVOID IMPROPER USE
- DO NOT USE ON INJURED SKIN.
- DO NOT SWALLOW.

# AGE OF ELIGIBILITY FOR USE ON CHILDREN

The medical device can be used on children zero years of age and older.

# DISPOSAL

After use, cotton should be disposed of in general waste.

 $If there \ are \ traces \ of \ polluting \ and/or \ potentially \ hazardous \ materials \ and/or \ substances \ in \ the \ cotton, \ dispose \ of \ it \ in \ biohazardous \ special \ waste.$ 

Plastic packaging (LDPE4) can be disposed of in plastic recycling.

Do not disperse or abandon the product and packaging in the environment for any reason. Never make the packaging available to children (individuals under 14 years of age).
